Metrolink's CEO discussed how our agency will work to implement our action plan to be a better neighbor. Topics included accountability and oversight, noise and emissions, and future opportunities for a modern facility and zero emissions. We also took this opportunity to hear community concerns as well as answer questions.

Central Maintenance Facility Action Plan-Current Status

Actions completed since April 11, 2019:

- Held Internal meetings with Metrolink's Department of Operations, Engineering and Public Affairs to discuss community concerns.
- 2. Reached out to METRO to conduct a new third-party noise study.
- 3. Scheduled meeting with Hood Emission Control Technology company for the first week of June.
- **4.** Developed overall action plan which will be posted to Metrolink website by June 9.
- 5. Presented action plan outline at a Community Meeting on May 9, 2019.
